(Annex A) Terms and Conditions:

- 1. There are no classes on public holidays. There will not be any replacement or compensation of such if classes fall on public holidays.
- 2. Fees will be billed at the start of every term. Term fees are to be paid before the commencement of classes. Classes will only be confirmed after full payment of the term fees has been received. There will be no replacement for missed class
- 3. Aquarian Aquatic School Pte Ltd (AAS) and Changi Beach Club (CBC) reserves the rights to turn down applications should there be less than the minimum number of students (i.e. 5 students for group class) in the class slot and shall not be obligated to provide any compensation to unsuccessful applications.
- 4. A penalty fee of \$30 (per month) will be imposed for payment overdue more than one month. A onetime \$50 administrative charge will be imposed for 2nd reminder after the one-month duration of fee payment request. Fees paid are non-refundable and non-transferable.
- 5. AAS reserves the rights to cancel classes or to find a replacement coach in the event classes coincides with scheduled activities (i.e. swim camp, swim meets). In the event class is cancelled due to coach unavailability, AAS reserves the rights to provide alternative dates.
- 6. One-month advanced notification by email or written letter is required for termination. There will not be any refund for the remaining classes.
- 7. In the event student has a long-term MC, we will review on a case to case basis. Documentation of proof must be submitted to AAS within 7 days of the issue date.
- 8. Students are to be present and required to bring their own swimsuit, goggles, swim cap and kickboard every class at the reporting area before proceeding for the class.
- 9. In the event of any disputes, the decision of AAS and CBC is final. Parents are not to intervene in the administration and coaching at the pool premises at any time.
- 10. All parents and students are to adhere to the CBC byelaws and all rules and regulations of the pool and facilities.
- 11. AAS and CBC reserves the right to refuse entry to students and/or parents due to misconduct, destructive/disruptive behaviour, and/or accidents at the pool premises.
- 12. AAS and CBC shall not be held responsible for any injuries sustained and/or accidents that may occur at the pool premises.
- 13. Non-members are not allowed to park in the Club's car park. However, drop offs and pick-ups shall be permitted. The Management and staff of AAS and CBC will not be held liable for any loss of/damage to property, theft or car park fines at or in the vicinity of the Club's premises.
- 14. AAS and CBC reserves the right to amend these terms and conditions without prior notice.
