1. All applications must be completed in full. Please submit photocopies of (1) Applicant's NRIC / Passport. For Applicants who are Singapore Permanent Residents, you are required to submit a photocopy of your re-entry permit showing unlimited access & entry into Singapore.
2. All applications forms must be submitted to the Club together with payment of all entrance fees, membership fees and other charges payable, amount of which is determined by the Club from time to time. The Club would not consider your application, until full payment is received by the Club. If you are paying by cheque, please draw a crossed cheque in favour of "Changi Beach Club". For payments either by cheque or credit card, payment is considered received only when the amount has been credited to the Club's accounts and not before. Receipt of cheque or credit card slip by the Club does not constitute receipt of payment of the amount payable.
3. The receipt of the amount payable upon the making of the application does not constitute acceptance or admission as a Member of the Club. You will be informed of the result of your application in due course. If your application is rejected, all amount paid by you upon application will be refunded to you, in full but without any interest, by way of a cheque made in your favour.
4. The Club reserves the right to reject an application without assigning any reason.
